Thinking About Race

Thinking About Race (December 2018) – FGC Institutional Assessment

"For years, Friends of Color have told stories of racism and marginalization in their Monthly Meetings, at Gathering, in Committee Meetings, and at Central Committee. The stories include travel, hospitality, and many 'peculiar' traditions of Friends General Conference (FGC) and of the affiliated Yearly and Monthly Meetings. Some Friends of Color wonder why FGC needs to spend money on an assessment process when we have heard these stories. It is the hope of those Friends who have committed time, energy and resources to gathering this information that a historic review of the stories will provide a description of how deeply systemic racism is embedded in our culture. The stories, paired with a collection of qualitative and quantitative data collected during 2018, could not only help FGC Quakers of European Descent finally see the full complexity/depth of the problem but could inspire Friends to change how our language, our processes, and our unexamined traditions have pushed Friends of Color away from our community. This report reflects a desire for transformation that will strengthen our beloved community.

"... Vanessa Julye proposes white supremacy as a direct threat to living into blessed community where everyone has value.... White supremacy restricts the creation of a blessed community because it makes it difficult for people of color to be a part of the community. White supremacy is white dominance. In this culture, what is considered 'American' is really European-American culture. If you are a part of that culture and fit into that culture, you don't notice it. It is invisible. If you accept a structure as normal, there's no need to change it."

Getting Clear with a Clearness Committee

It has been said that if you give Quakers a task, their first action is to establish a Committee. Though no doubt said in jest, one can appreciate that within the Quaker Meeting the Committee is where important matters are considered. An Individual Member (or regular Attendee) can set up his/her own Committee – a Clearance Committee. The purpose of this Committee is to offer a safe and confidential space where one can air matters of serious personal significance, both large and small.

Parker Palmer, a Quaker expert on interpersonal communication, has written -- "Behind the Clearness Committee is a simple but crucial conviction: each of us has an inner teacher, a truth voice, that offers

the guidance and peace we need to deal with our problems. He went on to explain that..." because that inner voice can be obscured by both inward and outward interference, the function of the Clearness Committee is to help remove that interference so one can better discover one's own wisdom..."

After meeting with one's Clearance Committee, once or even several times, one soon realizes that the intent of the Clearance Process is not to "fix" an individual but rather to provide a supportive and confidential environment in which she/he will be respectfully and compassionately heard.

If you are facing a major life event; trying to resolve a conflict; or simply seeking a safe space in which to examine an important personal, professional or spiritual decision, consider bringing it privately to the attention of a Pastoral Care Committee member. You will then be able to determine if a Clearness Committee is the right alternative for you.

Annapolis Friends Meeting maintains two e-mail lists, Announce and Discuss, both for different uses by members and interested attenders who choose to join them. If you are not a member or a regular attender of Annapolis Friends Meeting, then these lists probably have little interest for you. Conversely, if you are a member/attender and have interest in one list, then it is quite likely you have an interest in the other, so feel welcome to join both if you wish. Most do. Joining (Subscribing) requires a review by the list manager or vetting by the Outreach Committee; but leaving (Unsubscribing) can be performed at your discretion in the manner prescribed below.

The **Announce List** is for announcing events of concern directly relating to AFM and is meant to be used more restrictively. Announce List members are invited to use

afm-announce@googlegroups.com

in order to:

- * request to hold members of the community in the Light.
- * announce births, marriages, ceremonies of commitment, illnesses, deaths, or memorial services.
- * announce AFM and committee/subcommittee meetings or changes to previously announced meetings.
- * announce specific Annapolis Friends, Baltimore Yearly Meeting or Chesapeake Quarterly Meeting business.

The **Discuss List** is for other more general concerns and more open discussion of issues or items that the list user believes of interest to the AFM community, e.g., items relating to peace or other Quaker testimonies, and for announcements of Quaker organizations and other groups with which Friends are affiliated. Another way of looking at

the AFM Discuss List is to consider it an AFM blog for your posting items of interest for discussion among the Meeting community. More leeway is granted in the use of the Discuss list, but always use discretion and consider whether the prospective post is actually warranted for wide dissemination on either list.

To subscribe to the AFM Discuss List, follow the same method above by sending a request for inclusion in the e-mail list to either

If you have any questions or misgivings about using either Announce or Discuss to address e-mails to those wider audiences, be clear about posting to AFM Announce, consider deferring to Discuss, or perhaps address e-mails to a more restrictive and specifically targeted audience (many fewer addressees). Additionally, when responding to e-mails sent out via Announce and Discuss, be very clear in your mind about your intention to respond to the entire list. Alternatively consider sending a reply to the sender with a specific e-mail addressed to that person alone, thus obeying common e-mail courtesy.

**Annapolis Friends Monthly Meeting (AFM)
Meeting for Worship with Attention to Business (MfB)
Twelfth Month, Second Day, 2018 (12/2/18)**

Present were: Wes J. (clerk), Phil C. (recording clerk), Ellen M., Martha B., Nan & Sky E., Peter M., Francis W., Barb T., Julie R., Elise E., Lynada J., Karen C., Jennifer D-M., Sue P., Kim F., Cairn K., Bill K., Mary D., Mary B., Martha L., Kim, Cecile T., Dot W., Jean C., Sheila M., Larry M., Ruth S., Sylvia O., and Ann R.

Our clerk welcomed Friends to MfB and remarked on the Meeting House's annual, "near-miracle" transformation for AFM Holiday Market. This year was, perhaps the most successful ever, based on customers, volume and proceeds. We gave with special appreciation to Cairn, market committee members, other Friends and family for their efforts – and for the return of the Meeting House to "normalcy."

(We noted concerns about storage of Market items on the front porch. Friends are reminded to use caution storing items around the new statute donated by Carol Brantley, pending its possible relocation.)

Wes also reminded Friends that today's Potluck will be our farewell to Leo Pickens and that 12/23 will be our annual Children's Christmas program.

For Nominating Committee, Elise offered an updated edition of our 2019 Slate of AFM officers, committees and liaison. Friends also thanked Wes for his 4 years service as Clerk of Meeting, and welcomed Martha B. the current Assistant Clerk as the new Clerk of Meeting. We also noted that various other Friends are finishing terms as committee clerks and thanked them for their service, including: Elise finishing on Nominating Cmte, Suzanne finishing with Children’s Religious Education Cmte, Barb T. finishing with Peace and Social Concerns Cmte, and Marcia O. finishing with Trustees; Peter M. also will leave Meeting House and Land Cmte — happily, all with continuing enthusiastic service on other committees.

For Peace and Social Concerns Cmte, Mary D. reported the committee’s discernment as to use of the \$4,340 available for our 2018 Quaker Causes allocation, as follows:

\$1,000 Light House Shelter
\$ 350 Winter Relief
\$ 100 FCNL
\$ 100 Samaritan Visit
\$ 100 Quaker House Fayetteville
\$ 450 William Penn House
\$ 450 Friends Wilderness Center
\$ 450 Ramallah Friends School Directors’ Fund
\$ 450 STRIDE Camping Scholarships
\$ 450 Afghan Women’s Fund
\$ 440 Quaker Voluntary Services

For Stewardship and Finance Cmte, Sue P. offered a current Treasurer’s report and Phil offered a second reading of the AFM CY19 Budget. (See attached.) As a highlight of the current Treasurer’s report, Sue noted that year-end contributions still are running several thousand dollars behind what is hoped for by year’s-end; but, with committees’ underspending and with our usual year-end surge in donations, we still hope to end with a surplus.

Phil noted, in the slightly revised 2nd reader edition of the 2019 budget, that several features differ from previous years, including:

- a) We have eliminated “unrealized gains” on stock investments as income, since we don’t actually withdraw these amounts and the stock market could drop and eliminate them.
- b) We have increased our Lighthouse contribution to \$2,000 and moved it from Quaker causes to a line item, indicating our intent to provide stronger and more consistent support Lighthouse.
- c) As a one time event, we will donate \$5,000 to Lighthouse in memory of Carol Brantley. (Originally, we expected this to support solar panels for a “Carol Brantley Light and Love” fund; however, Lighthouse has decided it would be more economical to participate in community solar & to use the “Light and Love Fund” for other residents’ needs.
- c) We will increase our annual support for Arundel Connecting Together (ACT) to \$1,350, sharing a voting membership contribution with the County’s NAACP.
- e) As another one-time expense, AFM will host BYM Interim Meeting in March and there is a line item to cover anticipated expenses of approximately \$1,500. We will invite participants’ contributions during the event, but still expect our net cost may exceed \$1,000 based on the last Interim hosted here. Our costs may be slightly higher because of our preference to use the Light House catering program.
- f) MHL has recommended that we begin use of a county recycling service that will cost less than \$100 for the entire year.

With the foregoing increased expenses, our (as-yet) below-budget year-end contributions, and possible loss of major rental customers, S&F Committee was concerned that we either could face a budget-shortage of many thousand dollars or

could need to initiate a fund-raising drive to meet “normal” annual operating costs. Rather than commit AFM to either of these, S&F has recommended underfunding our AFM building fund and some capital expenses recommended by MHL (e.g., work on the floor, replacing folding chairs, installing a new deck, making an annual increase by \$10,000 to our building fund). Collectively, these cut-backs could save over \$10,000 and balance the 2019 budget without a fundraising drive, even if a year-end surplus doesn’t materialize. If the hoped-for surplus does arrive (as it has most years by at least \$5,000), S&F could begin by fully funding the \$10,000 building fund contribution (now only \$5,900) and by reviewing other cut-back capital costs.

After discussion, Friends approved the proposed 2019 budget with the agreed plan to increase capital & building funds to their traditional levels if year-end contributions support this. Friends also suggested that, in 2019, a review of possible building and improvement plans is needed.

For Meetinghouse and Land Cmte, Kim reported various items:

a) She noted that this is the 20th anniversary of having members of the Wimbush family (Belinda and Jeannie) providing maintenance support at AFM. We are very grateful for their dedicated support to our community.

b) She also reported that Nan. E. will leave our kitchen subcommittee after many years of incredible service and that Cecile has agreed to be a new Building Use Coordinator (BUC) together with Sheryl Grier. Friends welcomed these service transitions.

c) Kim also reported that we soon will have a new online “Care Of The Meetinghouse Reminder System” with a list of tasks to be attached, thanks to efficient programming by Sheryl. And, as a new efficiency measure, we now have six new mailboxes in the AFM office—all assigned already.

d) Kim noted that our new recycling service will start this Tuesday via Anne Arundel County government, which will allow recycling of a greater range of items than the City of Annapolis. We can empty Meeting House bins into the large, blue, wheeled recycling can that usually will stay outside the kitchen door. MHL will have a plan to get this to the curb by Tuesday mornings.

e) As to our stewardship of the sculpture left to AFM by Carol Brantley, we discussed that this is a sculpture carved from local stone by an artist renowned in Zimbabwe, where there is a Quaker meeting. Friends are reminded that we should be protective of the statute and not use it for a support, to lean on, etc. MHL will discuss possible later moving of the statue indoors; preliminarily, we also have discussed placing it in the Memorial Garden, the Bartram Garden, or in the foyer, especially if there comes a time that we have more space. Outdoor care may involve oiling it on a hot, sunny day. Further MfB discussion, including an announce list request for input, also will take place before a final placement decision is made.

f) Finally, after lengthy discussions, MHL proposes a new, 24” x 36” sign to say

This will be installed below a larger sign that says “Annapolis Friend Meeting,” replacing the small sign with hours of worship. Our old sign has been in use for about 25 years. MHL will consider adding the worship times on a separate sign, on fliers, and this will continue to be available on the webpage. Friends approved this new sign.

Our Clerk thanked everyone for their participation with the understanding that our Clerk and Recording Co-Clerks would finalize these minutes.
